

1. The equipment used to perform the survey from which this map or plan is based included a Topcon 505-223 total station on a steel tripod.
2. The field notes upon which this map or plan is based have a closure precision of one foot in 100,000 feet and an angular error of 0 seconds per station. The map or plan was plotted using the least squares method and the closure error was 0.0000 feet at the subject property. The accuracy of the field survey was as follows: 02/29/2014.
3. This map or plan has been calculated for closure and is found to be accurate within one foot in 12,365/67 feet.
